#### 1.0 About Policy

At ELANTAS Beck India Limited, we are steadfast in our commitment to uphold the highest standards of human rights throughout our operations. Within our company and across our supply chain, we advocate fair labor practices. Our employees are entitled to safe working conditions, fair wages, and the freedom to organize. We categorically prohibit the use of child labor (any person who is under the age of 18 years) and forced labor.

This policy is applicable to all aspects of our operations, extending to employees, suppliers, customers, partners and all other stakeholders who are integral to our business activities.

All employees of ELANTAS Beck India Ltd. will be provided Human rights training while joining, and refresher sessions on human rights will be conducted as deemed necessary. We shall also train our suppliers, partners, contractors, and other stakeholders on human rights and expect their adherence to our policy.

We are dedicated to creating systems that enable the reporting and resolution of human rights issues and infringements. We will thoroughly and swiftly examine all reported concerns in an unbiased manner. ELANTAS maintains a strict stance against human rights violations and forbids any instances of bias, enslavement, forced labor, underage labor, human trafficking, as well as any acts of violence, whether physical, sexual, psychological or verbal. We are committed to taking necessary actions to prevent and tackle such behaviors. We stand by those who raise concerns about human rights violations, ensuring their protection and offering confidential channels to address grievances.
